

**MINUTES - REGULAR MEETING
BOONE TOWN COUNCIL
APRIL 20, 2006**

A regular meeting of the Boone Town Council was called to order at 6:30 p.m., Thursday, April 20, 2006 in the Council Chambers, 1500 Blowing Rock Road. Mayor Loretta Clawson presided. Council members present were Mayor Pro Tem Lynne Mason, Rennie Brantz, Janet Pepin, Bunk Spann, and Dempsey Wilcox. Town Attorney Sam Furgiuele was also present. Adoption of Code Amendment: §30.07 Public Comment.

WHEREAS, the North Carolina General Assembly has adopted, in N. C. Gen. Stat. § 160A-81.1, new rules governing public comment at regular meetings of municipal town councils; and

WHEREAS, the Town of Boone wishes to provide a regular forum for citizens of the Town and other persons to express their views on subjects of importance to them, and to provide the Town Council with a regular forum to hear the varied perspectives of persons on matters, whether or not they appear on the agenda of the regularly scheduled meetings;

NOW, THEREFORE, PURSUANT TO N.C. GEN. STAT. § 81.1, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF BOONE, NORTH CAROLINA, THAT SECTION 30.07 OF THE TOWN OF BOONE, NORTH CAROLINA, CODE OF ORDINANCES, IS AMENDED, AS STATED BELOW, IN RELEVANT PART, WITH NEW

LANGUAGE IN BOLD AND LANGUAGE TO BE REMOVED WITH A STRIKE THROUGH:

§ 30.07 ORDER OF BUSINESS

...

(G) Any person wishing to address the Town Council **at any regular meeting of the Town Council** ~~but unable to give advance notice prior to the council meeting shall fill out the card~~ **place his or her name on a sign up sheet** available for this purpose. ~~and hand it to the Town Clerk.~~ Such person shall be entitled to speak under ~~“Unscheduled Appearances”~~ **“Public Comments,”** subject to the following rules and regulations:

(1) Speakers shall be recognized in the order in which they have signed up.

(2) No person shall be allowed to speak for more than five minutes unless the presiding officer allows an extension of time.

~~(2) No person shall speak about an item already on the agenda.~~

(3) Should more than one person wish to make substantially the same comments regarding the same subject, or where a group of persons supports or opposes the same positions, the presiding officer may require that all such persons designate a spokesperson for their group to address the Town Council, and the presiding officer may allot a larger amount of time for the presentation of the group position by the spokesperson.

(4) When the number of persons wishing to address the Town Council during the “Public Comment” period exceeds the number of people who can safely be accommodated within the Town Council chambers or other location of the meeting, the presiding officer may require that all such persons select delegates from the groups of persons supporting or opposing the same positions to address the Town Council, and the presiding officer may allot a larger amount of time for the presentation of the group position by each delegate.

(5) All persons addressing the Town Council during the public comment period shall be treated respectfully by other persons in attendance at the meeting, and all speakers shall conduct themselves with proper decorum. Should any person present during a public comment period substantially interfere with the ability of a person offering public comment or engage in behavior which violates norms of accepted decorum, or should a person offering public comment engage in behavior which violates norm of accepted decorum, after warning such person(s) and, except in a situation where there is risk of harm to any person present, providing such person(s) the opportunity to alter their behavior to bring it into conformity with norms of accepted behavior, the presiding officer may direct that such person(s) be removed from the meeting. However, a person expressing positions which are critical of Town policies or actions, or criticizing the Mayor, Town Council Members, Town staff, Town Officials, or Town policies or actions, shall not on that basis alone be considered to have engaged in behavior which violates norms of accepted decorum.

(6) Unless the agenda is amended in accordance with this ordinance so as to allow action on an item raised during the public comments period, ~~t~~The matter presented by the speaker shall be for information.

(H) Items shall be placed on the agenda according to the Order of Business. The Order of Business for each regular meeting shall be, but not limited to, the following: adoption of agenda (regular and/or consent), approval of the minutes, public hearings, administrative reports, committee reports, unfinished business, new business, informal discussion **and public comment.**

Adoption of Resolution: Opposition to National Forest Land Sales.

RESOLUTION IN OPPOSITION TO NATIONAL FOREST LAND SALES

WHEREAS, the federal government has proposed to sell at public auction up to 200,000 acres of national forest land in order to raise \$800 million over the next five years as a one-time payment for rural school needs; and

WHEREAS, the federal government intends to auction off North Carolina and other state public lands in order to temporarily finance the Secure Rural Schools and Community Self-Determination Act, a program that the federal government has announced it will phase out in five years; and

WHEREAS, more than one-sixth of the land proposed for sale (55,862 acres) is located in the southeast of United States; and

WHEREAS, nearly 10,000 acres of national forest land proposed for sale is located in North Carolina, including 895 acres in the Croatan National Forest, 3,836 acres in the Nantahala National Forest, 2,780 acres in the Pisgah National Forest and 2,317 acres in the Uwharrie National Forest; and

WHEREAS, North Carolina has made a commitment to conserve land and add to the state's system of public parks and forests; and

WHEREAS, we agree with North Carolina Governor Mike Easley that the proposed land sale "violates all tenets of good public policy. It disposes of valuable, sometimes priceless public resources, removing them from public access for all time to provide a modest, one-time infusion of funds for the ongoing needs of rural schools"; and

WHEREAS, Carolina would receive only \$103 per acre from the sale of its public lands; and

WHEREAS, the Boone Town Council does not believe that America must sell its public lands in order to temporarily balance its budget; and

WHEREAS, the United States Forest Service is seeking comments from all interested individuals and organizations regarding the President's Budget proposal to sell our public lands.

NOW THEREFORE, BE IT RESOLVED that the Boone Town Council holds that the lands proposed for public auction by the federal governments are our national heritage and therefore opposes the sale of our state's irreplaceable resources for future generations;

AND THEREFORE LET IT BE FURTHER RESOLVED that the Boone Town Council will submit this resolution of opposition to the USDA Forest Service.

PUBLIC HEARING ON SWEET WATER DRIVE STREET CLOSING

Mayor Clawson opened a public hearing at 6:38 p.m. on the closing of Sweet Water Drive. With no public testimony, she closed the public hearing at 6:39 p.m.

CAC ANNUAL REPORT PRESENTATION

Sean Krause, Chairman of the Community Appearance Commission presented the following annual report to the Council:

Summary of Activities

The Commission spent the first four months of 2005 completing the proposed amendment to the Unified Development Ordinance (hereafter "U.D.O.") of Article XXII, titled Commercial Development Appearance Standards. Subsequent to proposal of this Article, a joint meeting of the Planning Board and Community Appearance Commission was held, wherein the proposed text was amended. After the eventual passage of the Article, the Commission turned its focus to existing properties which demonstrate a detrimental appearance, and future appearance guidelines for "Big Box" retail.

Appearance problems with existing properties consist of outdoor storage of materials strewn about the property, outdoor display, moth-balled buildings, properties which are condemned or condemnable, and occupied buildings which meet Minimum Housing or NC Building Code, but are in poor condition. The Commission is preparing draft wording for proposal to Town Council for the inclusion in the U. D. O. to regulate outdoor storage and display. However, the problem of "eyesore" (vacant/abandoned/dilapidated) properties is very complex. The Commission has met with Tuesdae Rice of the Downtown Boone Development Association regarding incentives to renovate such properties. Regarding penalties, the Commission has discussed the NC Nuisance Law, but is aware of the delicate issues surrounding its use. The Commission is developing a list of offending properties. Members will contact these property owners with their concerns and all available positive incentives towards remedy. If the owners make no improvements, the Commission will refer them to Council as possible subjects for

action under the Nuisance Law. Tax Increment Financing (T.I.F.) was also discussed as a possible source of revenue available for the improvement of appearance in the Town. However, it seems that it is available only to historic structures or larger blighted community zones, rather than individual non-historic structures. Therefore, the Commission recommended that Council investigate T.I.F as a possible source of funds to make improvements such as burial of power lines, creation/enlargement of sidewalks, and provision of street trees. This may be of special benefit to Howard Street.

“Big Box” retail establishments create a variety of challenges to our community. The Commission will explore these issues in the coming year, including a possible maximum square footage of such establishments.

During this year, membership of the Commission has changed. Mr. William A. Bake was assigned as a new member. Mrs. Joan McLaughlin was appointed for the remainder of Lila Petersen’s unexpired term. Mrs. Nan Chase requested to step down as Chair, and Mr. Sean P. Krause was elected as Chair. Mr. Terry Taylor was elected as Vice Chair.

Budget

The Commission expended no funds over the last year, and there is no expectation that a request for funding will be made for the 2007 budget year. However, the Commission feels that the Council may wish to make a budget allocation regarding Town Appearance in the following categories:

- 1. Demolition of properties under the Nuisance Law (owners may possibly be fined to recover demolition costs);*
- 2. Acquisition of properties under the Nuisance Law;*
- 3. Funding for acquisition of small properties or portions thereof for green space, public transportation nodes, or parks;*
- 4. Provision and connection of walking trails throughout town;*
- 5. Provision of small signage kiosks as places for handbills to be posted, rather than telephone poles, abandoned buildings, etc.*

WHEREAS, on the 16th day of March, 2006, the Council of the Town of Boone directed the Town Clerk to publish the Resolution of Intent of the Council to consider closing Sweet Water Drive in the Watauga Democrat once each week for four successive weeks, such resolution advising the public that a meeting would be conducted in the Council Chambers on April 20, 2006; and

WHEREAS, the Town Council on the 16th day of March, 2006, ordered the Town Clerk to notify all persons owning property abutting on Sweet Water Drive as shown on county tax records by registered or certified mail, enclosing with such notification a copy of the Resolution of Intent; and

WHEREAS, the Town Clerk has advised the Council that she sent a letter to each of the abutting property owners advising them of the day, time, and place of the meeting, enclosing a copy of the Resolution of Intent, and advising the abutting property owners that the question as to closing Sweet Water Drive would be acted upon, said letters having been sent by registered or certified mail; and

WHEREAS, the Town Clerk has advised the Council that adequate notices were posted on the applicable street as required by G.S. 160A-299; and

WHEREAS, after full and complete consideration of the matter and after having granted full and complete opportunity for all interested persons to appear and register any objections that they might have with respect to the closing of Sweet Water Drive in the public hearing held on April 20, 2006; and

WHEREAS, it now appears to the satisfaction of the Council that the closing of said street is not contrary to the public interest, and that no individual owning property, either abutting the street or in the vicinity of the street or in the subdivision in which the street is located, will as a result of the closing be thereby deprived of a reasonable means of ingress and egress to his property;

NOW, THEREFORE, subject to the reservation of easement to the Town of Boone for utility purposes as shown on a map recorded in the Book of Maps _____, page _____ in the office of the Watauga County Register of Deeds, Sweet Water Drive is hereby ordered closed and all right, title and interest that may be vested in the public to said area for street purposes is hereby released and quitclaimed to the abutting property owners in accordance with the provisions of G.S. 160A-299.

The Mayor and the Town Clerk are hereby authorized to execute quitclaim deeds or other necessary documents in order to evidence vesting of all right, title and interest in those persons owning lots or parcels of land adjacent to the street or alley, such title for the width of the abutting land owned by them, to extend to the centerline of the herein closed street (with provision for reservation of easements to the Town of Boone for utility purposes) in accordance with the provision of G.S. 160A-299(c).

The Town Clerk is hereby ordered and directed to file in the Office of the Register of Deeds of Watauga County a certified copy of this resolution and order.

Upon a motion by Council member Brantz, and duly seconded by Council member Mason, the above resolution was adopted by the Town Council at a meeting held on April 20, 2006 in the Council Chambers.

REQUESTED APPEARANCE - DAVID COOK

David Cook appeared before the Town Council to request sewer service only to Lots 1 & 2 of the Junaluska Overlook subdivision located off Junaluska Road. Town Attorney Sam Furguele opened the public hearing at 8:54 p.m. to hear sworn testimony from David Cook, Public Utilities Director Rick Miller, and Development Services Director John Spear. Mr. Cook stated his plans to build a single-family residence on each of the properties with one being his personal residence. He noted that he was denied water and sewer service at the January 2006 meeting of the Council. Mr. Cook stated that the property would not perk and referenced the information provided in a letter by Christopher Brantley of the Appalachian District Health Department

contained in the Council's information packet. Public Utilities Director Rick Miller stated that since the request for water and sewer was denied, the applicant is eligible to request sewer service only. Development Services Director John Spear pointed out that this property is in the rural growth area which encourages low-density residential and agricultural uses. Mr. Spear stated that in order to annex the two properties, all three lots of the subdivision must be annexed. With no other testimony, Mr. Furgiuele closed the public hearing at 9:08 p.m. Upon a motion by Council member Mason, seconded by Council member Spann, Council moved to grant the request for sewer service only since the applicant was previously denied water and has a hardship situation due to the property is not being able to perk with the condition that the applicant pursue the possibility of annexation with the other property owner in the subdivision.

REQUESTED APPEARANCE - DAVID RISK

David Risk appeared before the Town Council to request water and sewer service to four properties within a five-lot subdivision located off Deerfield Road. Town Attorney Sam Furgiuele opened the public hearing at 9:16 p.m. to hear sworn testimony from David Risk, Public Utilities Director Rick Miller, and Development Services Director John Spear. Mr. Risk explained that this subdivision includes four vacant lots along with a lot on which his private residence is located. He stated that the property has not been able to perk and that if he is not granted water service, he would be happy to dig wells for each of the lots and connect to the Town's sewer system. Development Services Director John Spear stated that although the Planning Commission, acting as the watershed review authority, has approved the subdivision, the final plat has not been recorded at the office of the Register of Deeds. Furthermore, Mr. Spear stated that if the subdivision is annexed, all five lots, including Mr. Risk's lot, would be subject to annexation. Public Utilities Director Rick Miller stated that the property is located in the primary pressure zone. With no further testimony, Mr. Furgiuele closed the public hearing at 9:26 p.m. Council member Mason voiced a concern about granting water to these properties with the current water situation. Upon a motion by Council member Wilcox, seconded by Council member Brantz, Council moved to deny the water request but to grant the request for sewer service with the following conditions:

- § Annexation of the five-lot subdivision
- § Connection to Town water service if it becomes available in the future

REQUESTED APPEARANCE - FRANK BOLICK

Ed Street, representing Frank Bolick, appeared before the Council to request water reallocation to property located off Highway 421. Town Attorney Sam Furgiuele opened the public hearing at 9:31 p.m. to hear sworn testimony from Ed Street, Public Utilities Director Rick Miller, and Development Services Director John Spear. Mr. Street began by stating that the lead tenant has visited the property several times and that a site plan could possibly be presented to the Development Services Department within six months. He also requested an extension of the water allocation. Council member Wilcox pointed out that Ordinance 05-01 requires the payment of a non-refundable availability fee with water allocation extension. Public Utilities Director Rick Miller stated the amount of the water allocation previously granted to be 5000 gallons per day. Development Services Director John Spear stated that this property is located in the ETJ. Upon a motion by Council member Brantz, seconded by Council member Wilcox, Council moved to grant the water reallocation subject to the payment of the non-refundable availability fee. Council member Spann voiced a concern with the project citing the desire of town citizens to see more mixed-use development.
